





Fig.1 Typical Forward Output Characteristics













Fig.5 Normalized On-Resistance vs. Temperature for Various Gate Voltage






















Fig.9 Capacitance vs. Drain-Source Voltage














Fig.12 Clamped inductive switching energy vs. temperature




Fig.13 Clamped Inductive Switching Energy vs. External Gate Resistance






Fig.15 Transient Thermal Impedance (Junction – Case)








