

Fig.1 Typical Forward Output Characteristics at TJ=25°C







Fig.3 On-Resistance For Various Gate Voltage










Fig.2 Typical Forward Output Characteristics





Fig.8 Maximum Power Dissipation Derating vs. Case Temperature









Fig.11 Transient Thermal Impedance (Junction - Case)






Fig.10 Capacitance vs. Drain-Source Voltage (0 - 1200V)






Fig.12 Safe Operating Area





